All leverage selections, whether fixed or floating, remain subject to our Event-Based Margining (EBM) policies.

Leverage adjustments are automatic and based on real-time equity. A lower leverage ratio increases your margin requirement per lot. This can significantly impact your margin level if you have large existing positions open at the time of the adjustment.

We strongly advise all clients to manage their positions and monitor their margin levels carefully, ensuring their account maintains sufficient equity to support their open trades through any automatic leverage changes.
